

UNIVERSITY OF SASKATCHEWAN EDWARDS MBA PROGRAM - 2009/2010

Saskatchewan Association of Health Organizations Award

- (1) Saskatchewan Association of Health Organizations will provide one award of \$1,000 for a student enrolled in the MBA program for the 2009/2010 academic year.

- (2) This award is open to students enrolled in the Edwards MBA program and who are taking graduate courses in health care administration. Annually one student from the Edwards MBA Program will be chosen based on academic achievement and financial need. The recipient will be chosen from those who have successfully completed the largest number of graduate level courses related to health care administration with the highest average on those classes and also demonstrates financial need.

- (3) The name of the recipient of the award will be announced at the Edwards MBA Banquet at the end of August. Only the name will be announced, no money will be given at this time. See point (4) below.

- (4) It is the expectation that the recipient will attend the SAHO conference in March 2011 and receive the award in person. Should the recipient not be able to attend and receive the award, it would be their responsibility to ensure a representative is in attendance on their behalf to accept the award. The recipient will be given a complimentary pass to the conference, however should they not be able to attend in person this is not transferable to anyone else.

- (5) **The deadline date for applications is Wednesday, June 30, 2010.** Submit applications directly to the Edwards MBA Office, Room NC 121 Edwards School of Business.
